 - ii. If the Authority is specifically informed of the cancellation before 10.00 am on the last working day previous to the Rest Day or Public Holiday for which the labour is ordered.**
 - iii. If cancellation is effected during the work period for which the labour was ordered, the standby charge shall apply.**
 - iv. In all other cases, cancellation fee shall be payable for cancelling or amending order.**

Shut Out Cargo Rates

- When cargo has been delivered to transit shed for loading to specific vessel and is subsequently shut out and remains in a transit shed at the expiry of free storage period. The overtime rates shall apply
- If re-delivered to the shipper within 24 hours of being shut out. A charge of RM3.00 per tonne or part thereof shall be made .

Free Storage Period:-

- i) Import Cargo – Seven (7) Working Days
- ii) Export Cargo other than Timber Products – Seven (7) Days
- iii) Export Timber Products – Fourteen (14) Days

Surcharge For Receiving and Delivery of Cargo on Sunday & Public Holiday

**The normal receiving and delivery charges shall be subject to a surcharge of 50% for goods received or delivered though the Authority premises on Sunday and Public Holiday

- I. RM 50.00 per survey for 1st 2 hours;
